Winding Timepieces. "I have been doing a little figuring on time," remarked an erratic citizen yesterday, "and I have reached some rather interesting conclusions. I want ed to find out how much time man con-

sumed in keeping tab on time, and I found that, if the whole world is considered in the computation, years would be crowded into a second of time. "To illustrate what I mean, take a

city where 100,000 watches are wound up every day. Now, it takes probably an average of 15 seconds to wind a watch. It would take, then, 1,500,000

seconds to wind 100,000 watches. This would mean 25,000 minutes or 530 hours and 10 minutes, or 25 days and 16 hours. I suppose there are in the city of New Orleans 100,000 watches and clocks to be wound up every day, so that nearly a month is spent in the city every day in winding watches and clocks.

"One man in a year's time would consume 5,475 seconds in winding his watch if he is prompt about it and is willing to give 15 seconds every day to this useful article. This would mean several hours during every year that he kept up the practice. Allowing 35 years as the average life, a man would spend 191,525 seconds, or 3,190 minutes and 41 seconds, or 530 hours and 10 minutes, or 22 days and 20 hours, in winding his watch."-New m. Orleans Times-Democrat.



To cause the destructive cankers which girdle the limbs the germs of the lisease must get through the tough outer layer of the bark into the growing layer beneath, the cambium. 'An injury to the bark of some sort is necessary to this entrance, for the fungous threads cannot penetrate the unbroken bark. in a small, dead branch which was Sun scald as well as mechanical abrasions may cause such injuries. The bark is killed by the sun and frost and cracks, or peels, when the germ finds tirely. It lived long enough, however, ready entrance and rapidly extends the lnjured area in canker form.

Sun scald or sunburn is a common trouble in this state, probably more common than generally supposed, especially on tender varieties. The long areas of reddish bark on the south and southwest sides of limbs and young trunks are inconspicuous when they first are scalded and so escape notice, but they are all too common and may become the seat of serious harm to the trees.

Trees of tender varieties should be protected from the direct rays of the sun by training them to low, thick heads which shade both trunks and branches. Additional protection may be given by a coat of whitewash upon the trunks, which helps to prevent absorption of the sun's rays and also exerts a favorable influence upon the bark itself. A good mixture is:

In addition to the protection from sun scald thorough spraying with bordeaux mixture and care to prevent accidental injuries make up the preventive treatment. The larger diseased limbs may be saved from complete loss by cutting them off back of the cankered area and inserting cions of the same variety.

Only a few specimens showing effects of this trouble have been found in America, some coming from Nova Scotia and a few from Cortland county in this state. The cankers are unlike those of the spheropsis and are caused by a different fungus, Nectria ditissima. They are well represented by the





#### Forcing a Bull Calf.

Use of corn, oats, bran and middlings equal parts for concentrates, says The Breeder's Gazette. ## HANDY MOVABLE FENCE.

#### Easily Made and Suitable For Fencing Hogs or Cattle.
