An exchange says: "If you do not know what to do with that pile of old tin cans that has accumulated in your back yard during the winter, just arrange them in a low pyramid, cover them with good soil, and you will have a splendid mound on which to grow your flowers. The cans can hold a great deal of water after a rain, or after using a hose on the mound, and the effect of its constant presence is seen in the growth of the plants." Attorney General Blair has furnished the state game warden with an opinion to the effect that the new fish law which provides that trout less than seven inches in length may not be taken from any of the streams in the state, does not repeal the special act of 1901 fixing a limit of eight inches for trout taken from the Au Sable river and its tributaries. He also holds that the new fish law makes no change in the open season for catching black bass, and the law now provides as before that this fish may be caught lawfully after May 20.

Weekly Crop Bulletin.

Below is the weekly climate and crop bulletin of the Michigan section of the U. S. department of agriculture for the week ending Monday:
 The mean daily temperature for the week ended May 18 was 59.6 degrees, or 6.3 degrees above the normal; the average total precipitation was 0.29 of an inch, or 0.54 of an inch below the normal; the sunshine average 70 per cent of the possible amount.
 In the Upper Peninsula ample showers and moderate temperature have greatly advanced the season. In the Lower Peninsula the past week was warm and very dry, particularly in the southern and central counties. The soil is becoming parched and almost too dry for plowing. The warm, dry weather has checked germination and been detrimental to wheat, meadows and pastures, which are very slow and much in need of more moisture. Corn planting is quite general in all counties of the Lower Peninsula, but rain is needed to forward its germination. Early sown oats have come up nicely. Rye has made fair progress, but is rather short and beginning to head in southern counties. Barley and peas have come up fairly well. Sugar beet seeding has made good progress and early potatoes are mostly planted.
 It now appears that early peaches, early cherries and strawberries suffered the most from the frost of May 1st and 2d, fair yields are still indicated. Apples, plums and pears are blossoming plentifully.

 The board of supervisors of Iosco county met in the court house in the city of Tawas City, said county, on Thursday, the 30th day of April, 1903, pursuant to adjournment from yesterday.
 The board was called to order by chairman pro tem Jackson, who ordered the clerk to call the roll.
 The following supervisors answered to roll call: Supervisors Anschuetz, Armstrong, Brown, Dutton, Glendon, Jackson, King, MacFarlane, McCausland, McDonald, Muncey, Patterson, Rawden, Renno, Richards,



Rollin, Searle, Sutherland, Venners, Walker, West—21. Quorum present.

The minutes of yesterday's meeting were at this time read by the clerk.
 Chairman Sutherland entered and took the chair.
 Moved by Rawden supported by Jackson that in the resolution passed at yesterday's session regarding the raising of a special highway tax in Sherman township, the words "special election" be stricken out and the words "special township meeting" be inserted instead. Carried by unanimous vote.
 The clerk then read the resolution as corrected.
 Moved by McDonald supported by Brown that minutes be approved as read. Carried—years 19, nays 0.
 Bill of W. B. Kelly, fees in inquest on body of J. Jenkinson, was presented to board as a matter of unfinished business.

 Bill of H. M. Lood's Sons for wood furnished, amt \$1 50, was presented to the board. Moved by McDonald supported by Rawden that bill be allowed. Carried—years 20, nays 0.
 The bill of A. Stockman & Son for provisions furnished small pox patients, amount \$6 90, was presented to the board. Moved by Dutton supported by Rollin that bill be referred back for correction. Lost as follows: years 4, nays 16.
 Moved by Rawden supported by Brown that bill of A. Stockman & Son be allowed. Carried.

The Beet Industry.

The possibilities of the sugar beet are becoming greater all the time. When the beet sugar industry was introduced in Michigan, sugar was the only product and was considered a big thing for both the manufacturer and beet grower.

The manufacturing of alcohol from the low grade syrup proved a valuable discovery and increased the value of beets, now these new discoveries promise greater possibilities, and hold out to the beet growers greater inducements to become proficient in the handling of the beet crop, and to continue it on a larger scale, as the increased products make the beets of greater value and these profits must be divided by the manufacturers with the grower.

The sugar beet industry in Michigan appears to be but in its infancy and future developments will increase the profits of both the sugar men and the beet growers.

Duty of Citizenship.

The board of supervisors of Iosco county met in the court house in the city of Tawas City, said county, on Wednesday, the 20th day of April, 1903, pursuant to a call made by the county clerk upon the written request of one-third of the supervisors-elect of the county.

The board was called to order by county clerk Jno A Mark, who proceeded to call the roll. The following supervisors answered to roll call: Geo C Anschutz, supvr Tawas twp.

Moved by Patterson supported by Venners that Geo Sutherland act as temporary chairman. Carried by unanimous vote. Moved by Brown supported by Dutton that the election of permanent chairman and chairman pro tem be made a special order of business for 2 p m.

Moved by Searle supported by Patterson as an amendment that the election of permanent chairman and chairman pro tem be made a special order of business for 11:30 a m. Lost by following vote: yeas 6, nays 14. Vote was then taken on the original motion. Carried. Yeas 20, nays 0.

Moved by Macfarlane supported by West that chairman appoint temporary committee on claims and accounts. Carried, yeas 20, nays 0. Chair appointed supervisors Patterson, Dutton, Armstrong, King and Brown as temporary committee on claims and accounts.

On motion board took a recess until 1 p m. Afternoon Session. Board called to order by temporary chairman Sutherland. Quorum present. On order of chairman the temporary committee on claims and accounts retired to their room.

Two o'clock having arrived, special order of business, viz: election of permanent chairman and chairman pro tem, was taken up. On motion chair appointed supervisors McDonald and Anschutz tellers. Board then proceeded to election of permanent chairman.

Total number of ballots cast 22, of which supervisor James A. Jackson received 15, supervisor Rawden 6, and supervisor Patterson 1. Supervisor James A. Jackson having received a majority of all the votes of the supervisors-elect, was declared elected chairman pro tem of this board for the ensuing year.

15. All supplies for county officers, when amount needed exceeds \$5, shall be purchased by committee on public buildings, supplies and repairs. March 1903, journal 6, p 13.

16. County canvassers shall be allowed \$3 per day and 10c mileage when meeting to discharge their duties. Oct 1902, journal 5, p 431.

17. Chairman shall appoint three committees on claims and accounts to be known as committees 1, 2, 3. To committee No 1 shall be referred all claims for purchases of materials and supplies and miscellaneous accounts.

Moved by Patterson supported by Dutton that report of committee on compilation of rules be accepted and adopted. Carried by unanimous vote. The following resolution was offered by supervisor Rawden:

Resolved, That the township of Sherman is hereby authorized to raise during the current year by tax upon the taxable property of said township, the sum of nine hundred and fifty dollars (\$950.) for the purpose of building and repairing the roads and highways of said township.
