A Letter From Chas. Story.

Kennewick, Wash., Sept. 7, '06
Friend Len:—

Herewith find check for \$1.50 for my subscription. We enjoy reading the paper and it helps us to keep up with our friends around Tawas.

The west is a great country and the people of the east know as little about the west as about a foreign country, the people are so different as a whole. While there are many people in the east like the western man, there are many people in the east not like the western man. A close, stingy man is hard to find here and as a rule they are quick-thinking, brainy men who deal as quick as the flash of the eye. Conservative, careful eastern men who come here soon get to do business in this way. I remember a man in your city who wanted to buy a property on front street. He, after deciding 't'at he wanted the place, looked it over, then took his wife over the place next day, then every day for a month he walked by the place and sometimes would go on the opposite side of the street and sit down for an hour or so to consider. It took him over a month to purchase, and a great deal of haggling about the price was done.

In this country the place, if the price was right, could be sold five times in the month. I had a friend who wanted me to select him a small tract. I did so and arranged with the owner to describe the place by letter, and the friend if satisfied was to notify me by wire; I was then to pay \$50 to bind the bargain and the friend was to forward the first payment. Instead of sending a wire as directed the man wrote and enclosed the \$50 and by the time the letter was received the place had been sold twice, the second time for \$125 per acre more than my friend had to pay. That was last spring and today the tract could not be bought for less than \$900 per acre, just 100 per cent difference.

Kennewick is a new country and this season the trees are three years old. This year fully demonstrated how great a peach country this is, also how well grapes do here. I send you a photo of a 3-year-old tree from which 7 boxes of peaches were taken, then sold at \$1.50 per box. When the tree is five years old it will produce from 20 to 25 boxes of 20 pounds each. This picture was taken from the orchard of W. H. Haxton, and he will receive \$3,000 from a 5 1/2 acre orchard. I wish I had a cut made of the picture so that your readers might see the same. Last season Mr. Haxton took \$1,565 from two acres of grapes.

I fully understand that your readers will not believe these statements, but nevertheless they are true and can be proven.

Kennewick has grown from nothing in 3 1/2 years to a beautiful city of 1500 people and will double in population in one year. Our company is now erecting a \$30,000 concrete hotel and two large concrete store buildings and there are 12 concrete and brick buildings now being erected in the city.

Land has risen from \$40 per acre with a perpetual water right to as high as \$1200 per acre where the improvements are extra good. For all this, out in the valley 4 miles from town good land can be bought for as low as \$100 per acre with water.

Since I wrote you last our company has built a town called Hoyer at the east end of the valley. The name is taken from H. A. Hoyer, the president of the company. The place now numbers about 600 people. This will show you how fast eastern people are coming in.
