The announcement that the army is to dig the Panama canal must have surprised the people who thought an army's business in time of peace is merely to stand around with a chip on its shoulder.

British Ambassador Bryce's "American Commonwealth" contains a chapter entitled "Why Great Men Are Not Made Presidents." Now that congress is off his hands, Mr. Roosevelt may find time to discuss that chapter with Mr. Bryce.

Alexander Graham Bell, the inventor of the telephone, is a familiar figure as he walks about Washington for his recreation. He has white hair, white whiskers, and glowing pink cheeks. To a newspaper man who remarked that he approached a great inventor with some trepidation, Mr. Bell replied: "My hat is off to newspaper men as the greatest inventors of the age."

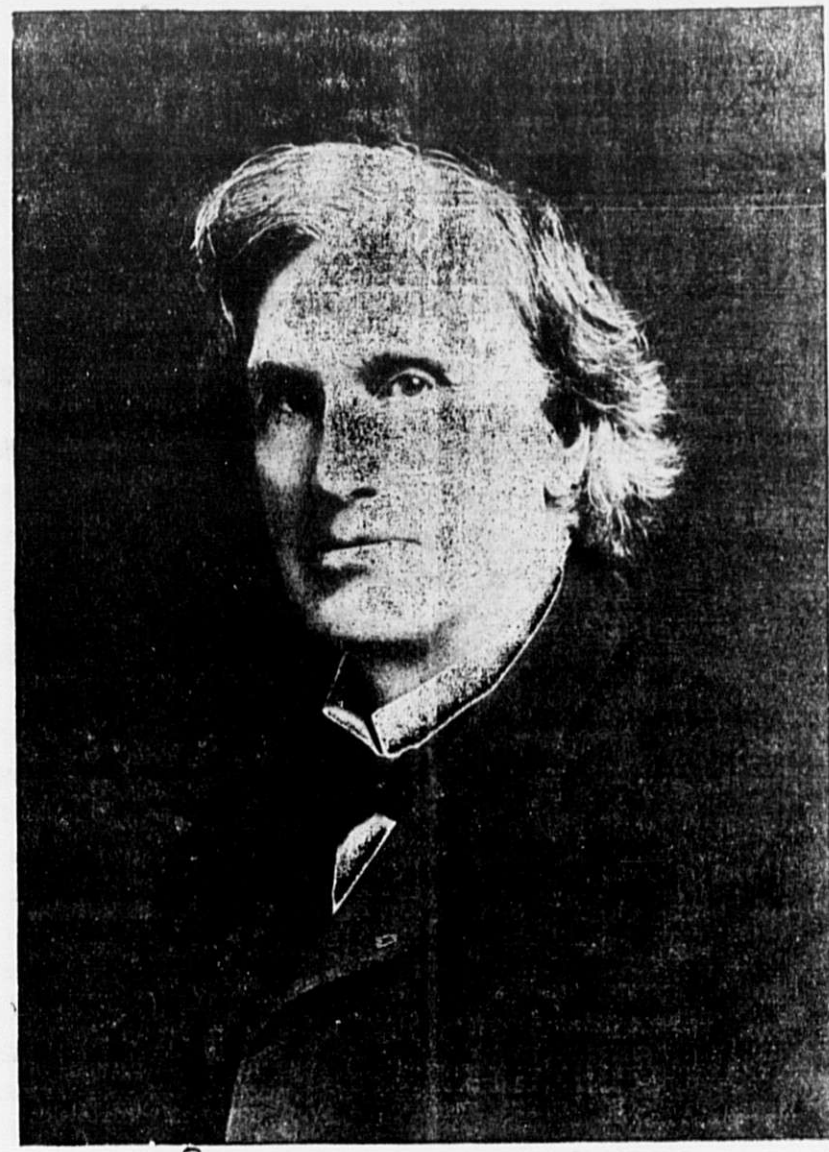
None but taxpayers may vote on a proposition to bond a city, is the decision of the supreme court in the case of John A. C. Menton against Miles P. Cook. In 1905 Flint voted to bond for \$50,000 to build a city hall. Menton, an elector but a non-taxpayer, was refused a vote, and brought suit against Cook, election inspector. The supreme court affirmed the decision of the circuit court against the plaintiff.

Senator Cropsy has introduced a bill the purpose of which is to clip the wings of Frank Neal, an assistant secretary to Gov. Warner. Neal draws \$100 a month as secretary of the state board of mediation and arbitration. The bill gives the members \$5 per day for actual services and provides that the secretary shall be chosen from among the members of the board. "This board only meets once in seven years," said Senator Cropsy, "and Neal is getting too much money. It is an imposition on the taxpayers."

The usual padding of mails out from Washington during the weighing season is now in full force. The Bay City Times states that during the past week a large number of maps weighing three or four pounds each have been received there under the frank of Senator Burrows. The peculiar thing about these maps is the fact that they are out of date, and of no practical use, there being a number of more recent publications. This is a fair sample of how efforts are being made to rob the government for the benefit of the railroads.

There is no doubt that a large percent of the degradation, disgrace, ruin and crime among the young, springs from the habit of night prowling, corner loafing and kindred acts by both sexes in city, town and hamlet all over this broad country. Any person who keeps his or her eyes open knows this. Hundreds of boys and girls are out at night, and we all know that many influences for evil and none for good surround them continually. A curfew restriction may be derided as old fashioned and puritanical, but the fact remains that there is vastly less night prowling in towns that have a curfew ordinance and enforce it.

According to the statement issued last week the net earnings of the steel trust for 1906 were \$156,624,273. It also shows that the trust paid about \$150,000,000 in wages to 202,457 employees. Of course this includes the salaries paid head officials, who also came in on the dividends. It is probable that the laboring men who actually earned these enormous profits, really got less than \$2.00 per day. How much better it would be for the country at large if it required at least a portion of the enormous profits of such corporations as this to be added to the wages of the common laborers. The increased demand for all products would thus give us a stable prosperity.



HON. JOHN R. CARR

Candidate for Associate Justice of the Supreme Court

Herewith is a cut from a recent photograph of Hon. John R. Carr, of Cassopolis, candidate on the democratic state ticket for one of the associate justices of the supreme court. He is a graduate of the law department of the University of Michigan. On receiving his degree, B. L., in May 1870, he commenced the practice of law in Cassopolis, where he has resided ever since.

He has been circuit court commissioner of the county two years, prosecuting attorney four years, a member of the board of education fifteen years, and judge of the 36th judicial circuit six years. The above is all of the offices he has ever held. He is an ardent believer in the rigid enforcement of the laws.

The supreme bench is composed of eight judges, and they are all republicans. The office is not a partisan one, and the bench should be non-partisan. Two associate judges are elected every two years. The law placing the election of the judges at the town meeting, in the spring, shows that it was the intention of the lawmakers to place the election of the judges away from any politics.

Judge Carr has been a member of the Presbyterian church since early manhood, and has served as ruling elder in the Cassopolis church for the past fourteen years, and is at present the Sunday school superintendent.

By habit, experience and education he is well qualified for the high office to which he aspires. You will make no mistake in voting for him.

Come to the election April 1st, and put a cross, (X), opposite the name of John R. Carr.

Bible and Cards.

Over 8,000,000 Bibles were sold in this country last year, but it is not likely that they were subjected to the same wear and tear as the millions of poker decks that were sold at the same time.—Washington Post.

It may be so, son, it may be so. But you pert paragraphs of the daily press are much less distinguished for the drawing of morals than for the adornment of tales. It strikes thinking people that the sale of eight million copies of the Bible in a single year is a rather significant fact. It means that one person out of every ten of our population bought a Bible last year.

Why this phenomenal demand? Certainly there must be something between the covers of this old book that the people want. On the very low level of demand and supply it must be said the book fills a great need or a great longing of human nature. Its friends contend that it finds the human heart at lower depths and at loftier heights than any other volume in all the world; that it fits the human soul as the sea fits the land, as the air fits the mountains. Certainly, as attested by the fact that men buy it by the millions, there must be something in the claim of its friends.

Eight million copies a year. Is there some intimate connection between this Bible buying and the great obvious revival of the national conscience, or is it only a coincidence? Is it not plausible to connect the growing spirituality of our day, as shown by the national sensitiveness, as shown by the flaming out of moral protest against wrong doing in public and private affairs, with the phenomenal growing interest in the Old and New Testaments?

We are holding no brief for the promotion or defense of the Bible. It is abundantly able to take care of itself. But is it not possible that the Post paragrapher is mistaken in comparing the thumbing of the leaves of the Bible with the shuffling of the cards in the poker deck? There must be something in the old book—which has always had a hold on the Anglo-Saxons—that ministers to some great spiritual hunger and thirst. Else eight million people last year did not know what they wanted.—Sgo News.
