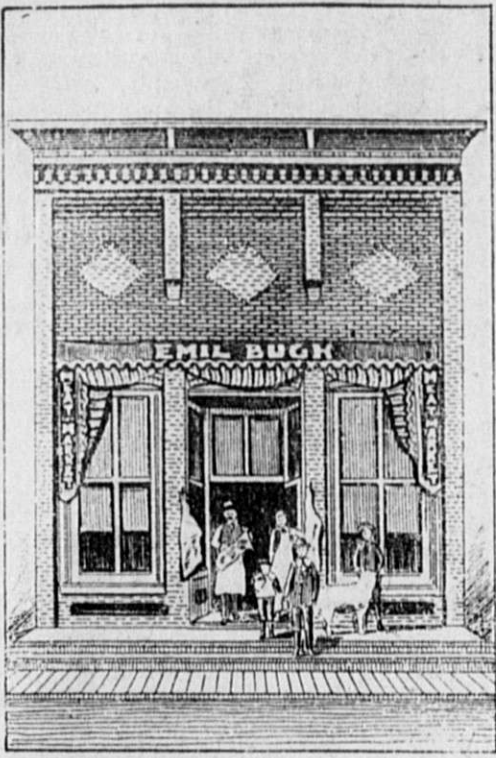

It is said that one-eighth of the revenues of the United States is derived from the tobacco industry in one form or another.

The United States has more newspapers than any other country. Every week day there are 19,000,000 copies issued and on Sunday the number is 11,500,000 copies.

In New York city alone the great works of tunnels under the city and river, railway terminals and depots, water supply and other similar enterprises now in progress aggregate the enormous sum of \$625,000,000, or more than four Panama canals, says Popular Mechanics, while three of the undertakings amount to \$100,000,000 each.

The mosquito family is a large one, as might be suspected. The experts have captured, identified and classified no less than 125 different species. In addition to the simon pure mosquito, there are any number of counterfeits. Scores of them are so closely allied to the real thing in looks, buzz, and other characteristics as to be mistaken by the amateur as a member of the original family.

Surely the great margin of \$8,000,000,000 between the \$4,000,000,000 received by the farmer for one year's crops, and the \$12,000,000,000 paid for the same crops by the consumer, is well worth looking after, and these are the figures given us by Secretary James Wilson of the department of agriculture. Thus the middlemen, because of their knowledge of the sale part of the farmers' business, receive \$2 for each \$1 received by the producer.

Representatives of three railroads at a hearing before Railroad Commissioner Glasgow at Lansing agreed to follow his ruling on the freight rate for railroad ties. The roads admitted doubling the ordinary rate on inter-state shipment of ties in an endeavor to hold them in the state for their own use. Complaint of this was made by the Sterling Sons Co., of Monroe. The commissioner will undoubtedly rule in favor of the Monroe company.

### Michigan Good Enough.

During the last five years many hundreds of Michigan people have disposed of their goods and chattels and removed to the northwest provinces of Great Britain—Manitoba, Alberta, Assinaboine and Saskatchewan. They have been induced by the florid literature depicting this land of promise and milk and honey sent out by the Canadian Pacific railway for the purpose of getting people there and building up business for the railroad. In the June Review of Reviews, John W. Defoe, editor of the Winnipeg Free Press, sets forth in a clear and entertaining manner the strides that are being made by his country in population and general development, but he also sounds this note of warning:

"Many people come to western Canada under a misapprehension as to the facilities of homesteading, and in the consequence suffer severe disappointment. The homesteading army always keeps in advance of railroad construction, and it is therefore quite impossible to secure a homestead within a short distance of an established railway. Homesteading parties go far afield, trusting that in a couple of years, by which time they will need an outlet for their products, the railroad will reach them. Often this faith is justified, but sometimes the railroad is very long in coming. The person coming to western Canada with a view to securing free land from the government ought to recognize that this involves going twenty, thirty or even forty miles from existing railways, with inevitable pioneering hardships."

The foregoing may be accepted as true, Mr. Defoe has no reason to distort the situation, with which he is thoroughly familiar. The greater number of people prefer to live the little time they have to live, among civilized and enlightened people, where they can have the benefit of the educational and religious advantages and of social conditions. What they might gain in the fertility of

the soil braving the tornadoes and droughts in summer and the disastrous blizzard and extreme cold in winter in that region of isolation hardly compensates for the comforts and conveniences of Michigan. What Mr. Defoe says about the distance of valuable homesteads from railroad communication is worthy of serious consideration. Farmers who are well situated for present or prospective transportation facilities on this side of the line should think a second time before deciding to bury themselves in remote and uninhabitable districts farther north.—Ex

### "The Referendum."

"Laws enacted by representatives may be good and yet not be adapted to the needs of the people. That is, the will of the people may not acquiesce in the need for the laws. But laws enacted directly by the people will always have popular support, command public respect, and be stable and enforceable.

"The intelligence of the community recognizes that the American representative system as at present constituted, does not represent: First, because the people do not nominate; second, because the people cannot recall; third, because the people cannot compel representative action without the power to nominate and the power to recall public officers, or the power to legislate directly. The object of direct legislation is not to abolish representative government, but to secure truly representative government. Switzerland, with the referendum, has representative government; the United States without it, has irresponsible party government.

"The referendum would conserve the right of the people to representative government, and also the people's individual, political and property rights. Such a system is, therefore, conservative. Those who oppose the referendum prefer the irresponsible party system which exists, because under it the people do not rule."—Lewis Stoetson, in The Public.

### Oyster Shell Scale.

Many of the apple trees in northern Michigan are being seriously injured by an insect commonly known as the oyster shell scale. It thickly encrusts the smaller branches of the trees and by sucking out the sap checks their growth and sometimes destroys them. A tree that is badly infested with this insect will make but little growth and produce but a little amount of fruit. The oyster shell scale when full grown is about three-sixteenths of an inch in length, brown in color and pear shaped. Underneath will be found a large number of white eggs from which minute lice hatch in July which will soon settle upon the fruit and begin to secrete the shell.

Many of these insects can be destroyed if the trees are sprayed during July and August with kerosene emulsion made by dissolving one pound of soap in two gallons of hot water and, after adding one gallon of kerosene, churning it together by means of a pump until a cream-like mass has been formed. This should be diluted to make twelve gallons. To remove the old scales from the trees it would be well also to spray them as soon as the leaves are off in the fall, using five pounds of caustic soda and five pounds of lime in fifty gallons of water. If this is thoroughly applied, it will destroy all scale and the bark will have a healthy glassy appearance.

### Long Death List Due to July 4th Celebrations.

New York, Aug. 24.—Official tabulation of the death toll and the list of injured as a result of the last Fourth of July celebration in the United States has been completed by the medical authorities.

The grand total of dead and injured for 1907, directly traceable to the deadly toy pistol, the giant firecracker and the practical joke, is placed at 3,413, which is less by 1,000 than the returns for last year. The dead are 164 and the injured are 3,249.

The figures have been compiled by the Journal of the American Medical Association, the reports being received from trustworthy sources in all of the states. The statistics are printed in the issue of the Journal dated August 24.

Noteworthy, from the standpoint of the medical profession, is the number of deaths due to 4th of July tetanus.

Statistics were first collected by the Journal five years ago and in 1903 there were recorded 466 deaths from all causes chargeable to the 4th, 406 of these being tetanus cases. The

lowest number of tetanus deaths yet recorded is the present years showing.

"There can be no doubt that this decrease," comments the Journal, "is due entirely to two causes, one being a popular understanding of the grave danger that lies in blank cartridges and in the 4th of July wounds, and the other is the more thorough surgical treatment of these wounds by the practicing physicians and the frequent prophylactic use of antitoxin."

### A Wedding Write-Up.

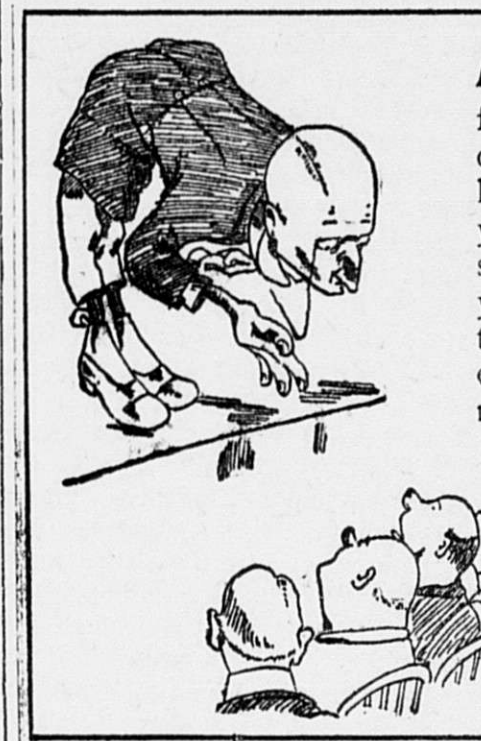
