The democratic state central committee of Minnesota, at a meeting last Friday, passed a resolution endorsing Gov. Johnson, of that state, for the democratic nomination for the presidency.

William L. Douglas, former governor of Massachusetts, is being prominently mentioned in connection with the democratic nomination for the presidency. He is today one of the ablest men of the country and the leading advocate of a revision of the tariff.

The new constitution will be voted on at the November election, as directed by the constitutional convention, according to a decision of the supreme court filed Monday morning. The court was divided on the question, six judges holding with the constitutionality of the convention's stand, and three contending for the April date.

"The Nu Spellin Leag of Amurrika has," says the Glasgow Herald, "just added 75 more words to the language. 'Tisis' and 'tung' are two of the wurst. Former United States Senator R. S. Pettigrew, of South Dakota, says: "The senate of the United States, which controls the government, is itself controlled by the interests. The people have nothing to do with electing their senators and the senate works in the interests of those who make its members. William H. Taft, the Roosevelt candidate, is perfectly

satisfactory to Wall street, hear what you will. I am a Bryan man, and have been ever since I bolted the republican party in 1896."

The government is asking for information concerning the condition of the highways along every rural delivery route; the number of miles of gravel road, number of miles of macadam and other kinds of road; also what is being done by the people to improve the highways? All of these questions simply go to show that the government wants to know if the people appreciate rural delivery enough to do their part by making the roads better each year.

### A Great Land Opening.

A Washington dispatch says: A number of exceptional opportunities will be offered this spring by the government for enterprising and intelligent farmers to secure choice farms on a dozen or more large irrigation projects which are now nearing completion.

Owing to the rapid narrowing of the limits of the unoccupied public domain, it is doubtful if these opportunities will ever occur again. It is probable, therefore, that the west will see one of the greatest influxes of homeseekers in 1908 that has been witnessed in many years.

The great fertility and wonderful crop yields from irrigated lands, and the favorable terms the government offers settlers, warrants the belief that before the year closes not a single farm will be without its entryman. These farms are located in North Dakota, Montana, Wyoming and Nevada.

A letter addressed to the Statistician, U. S. Reclamation service, Washington, D. C., will secure full information concerning the location, soil, climate, crop possibilities and terms of disposal.

### Another From Taxpayer.

Editor of Herald: My claim, that the townships have not their just representation on the board of supervisors, is substantiated by the call for the republican county convention. The 11 townships in the county are entitled to 18 delegates, and the cities to 11 delegates. This apportionment is made according to the votes cast in the several municipalities. This shows a greater injustice to the townships than did the property comparison, in your issue of two weeks ago. If the townships were represented by the number of inhabitants, they would have 18 members on the board, to the cities 11, instead of only 11 to the cities 14 as at present. But this is a condition that we inherited from the past.

Brother farmers, we can only remedy this evil by working together. I earnestly ask all Grangers, Gleaners and justice loving citizens to lay aside their party affiliations and join hands, and see to it when the legislature convenes next winter, that the city charters be amended, so that the cities will only have their just representation on the board of supervisors.

At the last two meetings of the board of supervisors, the sheriff and his deputies were paid for fees and expenses, \$1,503.60 (fifteen hundred and three dollars and sixty cents.) The members of the board of supervisors were paid for their mileage and per diem \$832.44 making a total of \$2,336.04. Verily, good government, is expensive.

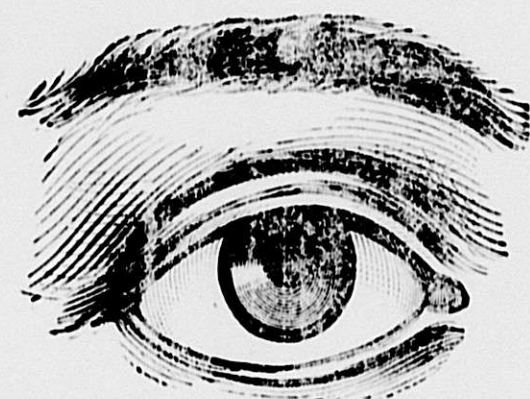
When the bunches are all gathered they are put on a car and carried to the wharf, where they are unloaded and again passed through a chain of hands to the ship's hold.

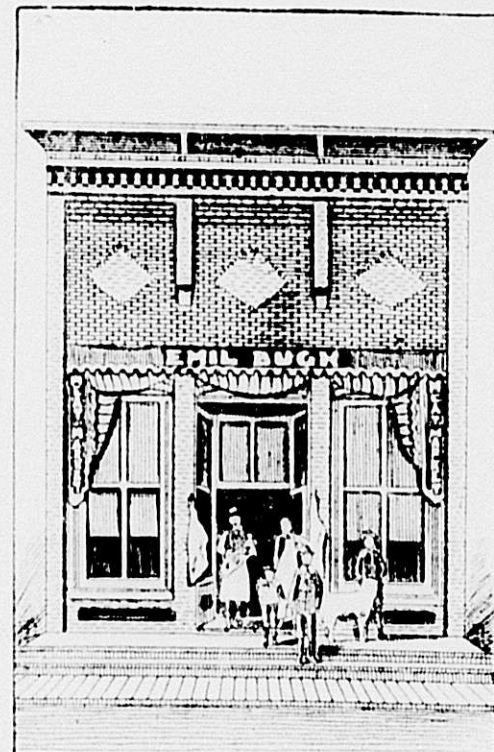
