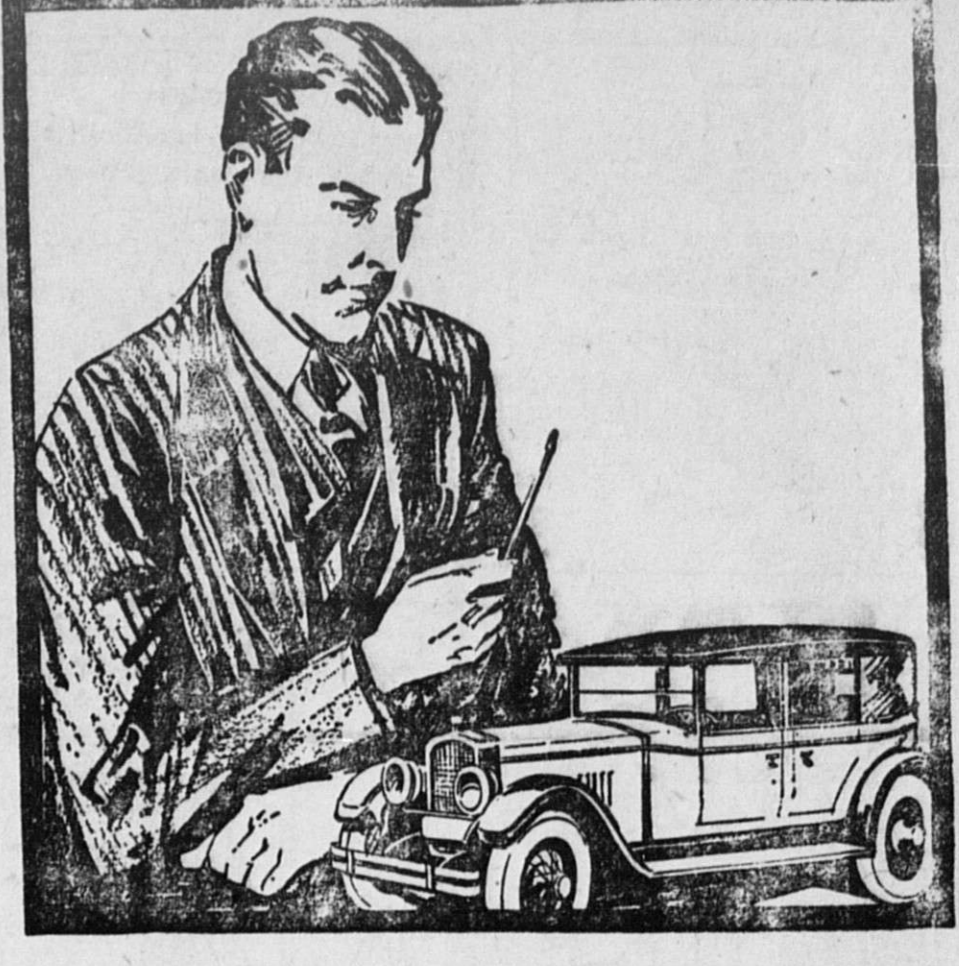
NOTICE
Order issued by authority of Act 230 of the Public Acts of 1925 making a closed season on Mink in the state until March 1, 1929. State of Michigan, County of Ingham, ss:

The Director of Conservation having made a thorough investigation relative to mink in the state recommends a closed season.

THEREFORE, the Conservation Commission having determined that mink are in danger of depletion or extermination and require additional protection by authority of Act 230 of the Public Acts of 1925 hereby orders a closed season on mink in the State of Michigan until the first day of March, 1929, during which time it shall be unlawful for any person to trap, hunt, take or kill any mink under penalties provided for by Section 5 of Act 230 of the Conservation Commission by: Howard B. Bloomer, Chairman, George R. Hogarth, Secretary. Public Acts of 1925.

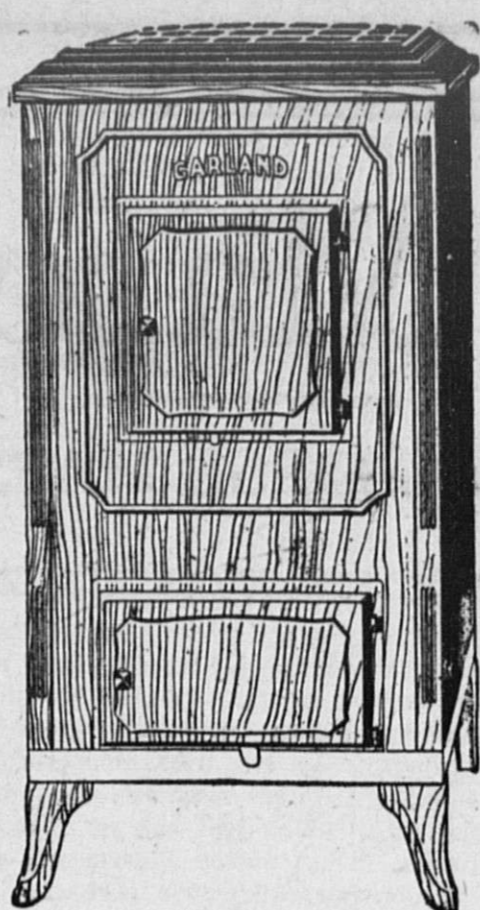
